Conference Registration Terms and Conditions

Behaviour

ASMIRT reserves the right to prohibit entry of any person to an ASMIRT event, or eject any person from an ASMIRT event based on behaviour deemed inappropriate by ASMIRT staff and/or its agents and others working under its authority.

Canvassing

Canvassing by delegates is strictly prohibited at ASMIRT events and forums. Promotional materials may not be distributed at the event/forum except by event sponsors and exhibitors. Delegates violating this policy will be asked to leave the event and ASMIRT members may have their membership revoked.

Goods & Services Tax

All pricing is inclusive of Australian Goods & Services Tax (GST 10%) and is subject to change without notice.

Program

ASMIRT reserves the right to change the program at any time. Every effort will be made to ensure a program of equivalent standard.

Recording of CPD Credits

CPD credits will not be automatically logged for this event. ASMIRT members and non-members will need to update their own CPD records at the conclusion of the event. Records of attendance are maintained on file by ASMIRT for auditing purposes. For all CPD queries, please contact cpd@asmirt.org

Registration and Payment

Registrations received after the closing date may incur a late fee. Payment in full is required by the event date. Early Bird registrations must be paid in full by the Early Bird cut off date - if full payment is not received by this date the full registration fee will be applicable. Registration places are limited and will be allocated on a strictly 'first in' payment basis. In the event that no space is available, you will be notified immediately. If you do not receive a confirmation email, please email conferences@asmirt.org to confirm that your registration has been received.

Payment

Credit card payments of registration fees can be made online. Payment can be made via Visa, Mastercard and Amex. All payments must be made in Australian Dollars (\$AUD). All credit card details are gathered through a secure PCI DSS (Payment Card Industry Data Security Standard) website and payment system so that all credit card details are fully protected at all times.

Early Bird Registration

All full conference registrations are eligible to register for the Early Bird Registration Price. All registration fees must be fully paid prior to the Early Bird cut off date. If a registration and full payment is not received by this date, the applicable full registration rate will be automatically charged.

Standard Registrations

Standard registration pricing will apply to any registrations after the Early Bird Rate has ceased. ASMIRT prefers to have all delegates registered prior to the event. Should any delegate wish to register during the event, they may do so (if there is availability) at the ASMIRT Registration Desk located in the foyer of the main conference rooms. No delegate will be allowed entry into the conference sessions or exhibition area without a valid registration name badge.

Registration Tickets

Delegates who have purchased any type of registration &/or ticket will need to check-in at the ASMIRT Registration Desk on arrival to the venue to collect their name badge. Please bring your confirmation letter with you and some form of identification such as a Driver's Licence or valid student card etc.

Registration Notice

ASMIRT member registration rates are not transferable to non ASMIRT members. This includes honours students but does not include HDR students and Intern / SPP / PDY's. A breach of this may result in an amendment in the amount payable for registration or cancellation of an event registration.

Sharing registrations

A conference registration is for one individual to attend the full conference program. One registration may not be utilised by several individuals.

Special Requirements
